## Society, Museum Eye 2011 Expansion

With the completion of restoration of the north room on the second floor, the Cedarville Museum now finds itself with two rooms available for exhibits on the first floor rather than one. That means more or expanded exhibits are possible.

Also, the new second floor room, with its unobstructed and much larger area than the room used in the past for historical society programs, offers the opportunity for a wider variety of activities.

Both the exhibit and program questions for 2011 will be addressed by the society board at its January 11 meeting.

Since moving into the present museum building several years ago, museum volunteers have created or updated six or seven exhibits each season. The added space that is now available for exhibits would permit the equivalent of at least four more exhibits. However, these added exhibits would require more time, money and volunteers to get them ready for the May 1 opening of the museum.

With the emphasis in 2010 on finishing the upstairs room, the historical society was able to hold only two evening programs, one being the two-night musical spoof on Cedarville history. The society board is pretty much agreed it would like more programs to take advantage of the new room. But again, more work.

Whatever the decisions on these matters, members can expect to enjoy the free Friday night outdoor movies, the Memorial Day activities, the Jane Addams Festival and the Christmas sing-a-long.

The party, held in sub-zero weather, was




a successful test of the room's heating system.
